



MARTIAL ARTS SEAMLESS FLOORING IMPORTANT SHIPPING INFORMATION & INSTRUCTIONS

1. Norbert's Martial Arts Seamless Floors consist of two components:
- COVER. Always rolled and coiled before being packaged first in blue or silver tarp material and then wrapped in a layer of corrugated material before being strapped securely to a pallet.

IF YOUR COVER ARRIVES PACKAGED DIFFERENTLY OR APPEARS TO BE CUT OR DAMAGED, DO NOT ACCEPT DELIVERY. PLEASE CALL NORBERT'S OFFICE AT (800) 779-1904 FOR INSTRUCTIONS .

- FOAM. Always supplied in rolls encased in blue or silver tarp material.

UNLESS FOAM ROLLS ARE EXTENSIVELY DAMAGED, ACCEPT SLIGHTLY DAMAGED FOAM ROLL SHIPMENTS. CUT FOAM IS USABLE.

2. Martial Arts Seamless Floor covers are made of 18 oz. vinyl material. While this is a very durable material, dragging your cover across any surface may damage it.

CARRY- -DO NOT DRAG COVER WHENEVER MOVING IT!

As noted above, covers are rolled, then coiled for shipment. To prevent permanent wrinkling you must unpack your cover immediately upon receipt and roll it out completely onto a warm flat surface enabling the material to relax.

Warmth accelerates the relaxation process so whenever possible covers should be placed outdoors in an area with day-long exposure to sun or indoors in a warm room. After several days, the material should be sufficiently relaxed and ready for installation. During that process the cover is stretched taut and any remaining small waves should smooth out.

3. **DO NOT SCHEDULE INSTALLATION UNTIL COVER IS READY!** Norbert's is not responsible for any charges you incur incidental to installation.

In summary, you are responsible for carefully inspecting Martial Arts Floor components before accepting delivery, for unpacking covers as described above as quickly as possible upon receipt, for transporting covers without dragging to desired location and for all charges arising from installation.
