Our Martial Arts Flooring consists of two components.

Filler is 1-3/8" thick cross-linked polyethylene. This foam is produced in sheet form with each sheet measuring 6' wide. Sheets are rolled to take advantage of the most economic shipping rate. You will receive the exact number of square feet needed to cover the area you ordered.

Foam filler can be easily cut to size using a utility knife. You will be responsible for determining the proper dimensions of finished pieces as well as configuring and cutting them to fit properly.

Vinyl cover material is manufactured exactly to dimensions you ordered. Covers are rolled, folded and banded to a pallet for shipment. Before we can begin manufacturing your Martial Arts Flooring, we must receive a signed copy of this document, as well as our **Important Shipping Information** document signed and dated. Your signature indicates you've read carefully, you fully understand the information provided, and agree to indemnify and hold us harmless for any damages or cost to replace/repair this product or its components resulting from your failure to comply with these instructions.

By signing this sheet you agree to the following guarantee terms: Equipment sold is guaranteed for a period of 1 year from the date of invoice against faulty manufacturing or defects in materials. The seller's sole obligation under this guarantee shall be to repair, at its option, replace, at its expense, any defective part or parts. Material claimed defective must be returned PREPAID to us for examination. Breakage caused by extreme usage will not be covered as it does not constitute defective material or faulty workmanship.
